The Founders have recognized the need for an umbrella body that will coordinate the activities of the diverse disciplines, and mobilize resources to coordinate Community development in Zimbabwe.

The Founders wish to establish a FOUNDATION for the purposes of spearheading and coordinating activities to identify projects and source individuals or entities from all over the world willing to participate in Community based developmental projects in Zimbabwe.

**HEADQUARTERS**

The headquarters of the FOUNDATION shall be situated at the office of Mr. Greyson Chipota  
No. 2 Garden Court 14<sup>th</sup> Ave/  
R.Mugabe way, Bulawayo

### **The objects of the FOUNDATION are:**

- 1 To positively encourage people, and especially the youth, to start businesses and support their community by providing jobs.
- 2 To establish Prosperity Centers in Zimbabwe and provide the Rules and Regulations for the Sound Prosperity Teams. <http://soundprosperity.org/prosperity-centers>
- 3 To source investors for Community projects, who will provide jobs, from all over the world.
- 4 To identify areas in need of development.
- 5 To positively influence development in various sectors of Zimbabwe's Industrial economy and lobby for Community involvement in those projects.
- 6 To initiate Enterprise Development through initiating programs and projects that alleviates poverty among the Communities in Zimbabwe and provide jobs.
- 7 To create a fund that sponsors Communities projects in Zimbabwe.

### **POWERS OF THE FOUNDATION BOARD**

1. Provide funds out of the FOUNDATION to an agreed agent to manage the day to day operations of the FOUNDATION, in pursuance of the purposes and objects of the FOUNDATION.
2. Appoint a coordinator, who is a Board Member and/or any such other person approved by the Board, to undertake the day-to-day management and any other specified matters of the Board on its behalf;
3. Set up Rules and Regulations for the Prosperity Centers and the Sound Prosperity Teams.
4. FOUNDATION has the power to take action if ANY of the Sound Prosperity Members is violating the [Rules for Sound Prosperity](#), which includes the [Terms and Conditions of MySPURT](#) and the [Rules for Sound Prosperity Teams](#).
5. APPOINTMENT AND REMOVAL OF PROSPERITY CENTER LEADERS, PERSONAL ACCOUNT MANAGERS, BUSINESS ACCOUNT MANAGERS AND KEY ACCOUNT MANAGERS  
These positions are appointed by the Board Members after application for any of these functions. A contract with time frame will be set up.

Signatures of three of the five board members is required for any operation.

### **FOUNDATION HAS NO POWER over:**

FOUNDATION has NO power over Sound Prosperity Teams, other than provided in the Rules and Regulations and on the REQUEST of a Team assist with problems. All TEAMS are responsible for their own Team and the success of their Team.

Charles Chindove is the Board Member appointed to be **Supporter** for the anonymously chosen Team Speaker of Zimbabwe. It might be so that each town has his own chosen Team Speaker in direct contact with Charles. This can be approved by Charles Chindove.

As long as there is no properly functioning Community Support Team, Greyson Chipota, living in Bulawayo, may be appointed by the Founders to be responsible for the funds in the communities. After the CSF is functioning properly, Pastor Greyson Chipota will withdraw.

## **APPRECIATION FOR WORK ON THE GROUND**

We want you all to be VERY clear that the Foundation is NOT intervening with what is done and will be done on the ground. Tremendous work has been done for which we all are grateful to the people pushing Sound Prosperity and SPURT forward.

SOUND PROSPERITY ZIMBABWE FOUNDATION strives to make all members responsible for their OWN lives. We teach them to be able to do that and provide the means. We CANNOT appoint ANY leader, otherwise the self-responsibility is gone. We do NOT want ANY colonization, not even in the form of a Leader.

## **EDUCATORS**

Sound Prosperity is training Educators to educate the people interested in Sound Prosperity and SPURT, the digital currency we are working with, to understand better what they can do and expect from SPURT. These Educators are certified and have a badge with a code on it, that can be checked. They will work on the ground in any of the areas they live.

The Educators are also trained in teaching Businesses how they can profit from working with SPURT and Sound Prosperity, hire more people and boost the economy.

## **SPEAKER**

We will appoint an official speaker for SOUND PROSPERITY ZIMBABWE FOUNDATION, so that information is officially provided by the board to the Zimbabwe people.
